Facts of the case are that on 08.09.2017 at 0500 hrs received a complaint from Suresh Uttamrao Dhawle, s/o: Uttamrao Chudaman Dhawle, age: 30yrs, pcc: Student, r/o: Railway quarters, 107B near Hingoli gate, Nanded, Maharashtra, cell no: 7385248663. In which he stated that on 27-08-2017 at 2030pm when his father Uttamrao Chudaman Dhawle s/o: Chudaman Dittal Dhawle, age: 57yrs occ: Electricrion in Railway department, r/o: Railway quarters, 107B near Hingoli gate, Nanded, Maharashtra, while he was returning to his residence by walk when he reached at Hingoli gate then one auto b.no: MH26N1235 came in a rash and negligent manner and hit to him due to which he received injuries on head and left shoulders. Immediately he shifted to Civil Hospital, Vishnupuri, Nanded for first aid. A case was registered in Cr no: 328/2017 u/s 279, 337, 338 IPC of PS Vazirabad Police Station, Nanded on 27-08-2017. For better treatment doctors advised to admit in Railway hospital, Lalaguda, Sec-bad on 28-08-2017 at 0900hrs. There the doctors advised to shift to Care, Hyderabad, on 28-08-2017 at 1100hrs he was admitted while he was undergoing treatment on 07-09-2017 at 1812hrs he was dead declared by the duty doctors. Hence he requested to take necessary action and to handover the dead body for funeral rights.

As per the facts of FIR and complaint it is came to know that on 27/8/17 at about 8:30pm when the deceased completed his duty and on the way to his home via Patsy near Hingoli gate, Wardha, near the Onr. Airo M.H. 264/1235, came & asked to him - to take him to the deceased Uttamrao Chaudaman Phasole road. He & Patsy and to left Phasole. They shifted to Civil Hospital, Vishnupur, Wardha after formal treatment & during reference to Pathology Hospital, Lalajda, Hyderabad for better fracture X-rays mounted to Hyderabad on 28/8/17 at 9am & admitted in Railway Hospital. They there down reference to Case Hospital, Bapatkilla for better fracture X-rays mobile undergoy fracture. The deceased Uttamrao Chaudaman Phasole died on 7/9/17 at 18:20 hours due to Head Injury.

As per the opinion of Panchayathdars & witnesses it is found that on 27/8/17 at about 8:30 pm when deceased completed his duty & on the way to his home, passing Hingoli gate, waded across One AUM MHS 641935 dished to him & received head injury. Immediately he was shifted to Civil Hospital, Vishnupur, nearest for treatment. After first aid treatment, the doctors referred him to Railway Hospital, Rajaguda, Hyderabad for further treatment. On 28/8/17 at 9 am admitted in Railway Hospital, Rajaguda for treatment but Railway doctors referred him to CARE HOSPITAL, Rajiv Gandhi for better treatment. On 28/8/17 at 11 am he was admitted in CARE Hospital, Rajiv Gandhi. While undergoing treatment he expired on 7/9/17 at 12:12 hours. As per the above facts & opinion of Panchayathdars, the deceased expired due to Accident surrounded as he was received head injury.
