

7. Sex, apparent age, race or caste.

Male, 19 years.

Blue black t-shirt, blue night pant, sandals both feet, silver metallic ring in left thumb ink stain present over left thumb.

8. Condition of the clothes— whether wet with water, stained with blood or soiled with vomit or foecal matter.

Night pant torned at left knee. Clothes blood stained at places. clothes handed over to the Police constable on duty.

9. Special marks on the skin such as scars, tattooing etc. any malformations peculiarities, or other marks of identification. State of the teeth.

Body identified by Police constable on duty. Teeth intact, 16/16.

- 1] Abrasion present over left frontal region, of size 5cm x 4cm, red in colour.
- 2] Abrasion present over left forehead, 5cm above lateral end of left eyebrow, of size 5cm x 3cm, red in colour.
- 3] Laceration present over left forehead, 2cm above lateral end of left eyebrow, of size 3cm x 0.5cm x muscle deep, margins irregular and infiltrated with blood.
- 4] Graze abrasion present over left shoulder, superior-lateral aspect, of size 8cm x 5cm, directed laterally downward, red in colour.
- 5] Graze abrasion present just above the left elbow, postero-lateral aspect of left arm, of size 7cm x 6cm, directed laterally downward, red in colour.
- 6] Abrasion present over right thigh, lateral aspect, 5cm below right anterior superior iliac spine, of size 1cm x 0.5cm, red.
- 7] Abrasion present over left knee, of size 3cm x 2cm, red in colour.
- 8] Abrasion present over left knee, just below injury no. 7, of size 1cm x 0.5cm, red in colour.
- 9] Abrasion present over left leg, antero-lateral aspect, 4cm above lateral malleolus, of size 2cm x 1cm, red in colour.

III. Internal Examination

19. Head

(i) Injuries under the scalp: their nature.

Under scalp contusion present over left fronto-temporal-parietal region, of size 12cm x 6cm, red in colour. Contusion present over occipital region of left side, of size 6cm x 5cm, red in colour.

(ii) Skull - Vault and base - describe fractures: their sites, dimensions, directions, etc.

Fracture line present over occipital region, of length 9cm, placed obliquely, margins irregular, infiltrated with blood. Communitated depressed fracture of skull present over right and left frontal bone of length 10cm. Fracture margins irregular and infiltrated with blood. Fracture line present over left frontal bone entering into base of skull extending into right maxillary fossa of length 13cm. Fracture margins irregular. Meninges intact, congested. Infiltrated with blood.

(iii) Brain - The appearance of its coverings, size, weight and general condition of the organ itself and any abnormality found in its examination to be carefully noted (weight M. 3 grams F. 2.75 grams).

Brain markedly congested. Diffuse subdural haemorrhage present. Diffuse subarachnoid haemorrhage present.
